Motion was made by Rosemarie Dearing and seconded by Paulette Moses to accept the minutes from the January 22, 2019 Public Hearing for Alfa Piping Corp. and Verdi Management LLC. Mr. Dolan stated no one from the public was present. All in favor, motion carried.

Motion was made by Paulette Moses and seconded by Marcus Duffin to adopt a Resolution giving preliminary approval of the Town of Babylon Industrial Development Agency to grant certain financial assistance to Harold Levinson Associates, LLC in connection with the acquisition and installation of certain major production equipment and machinery for its facilities located at 140 Carolyn Blvd.
