Motion was made by Rosemarie Dearing and seconded by Paulette Moses to accept the minutes from the October 11, 2016 IDA/IDC Board Meeting. All in favor, motion carried.

Motion was made by Rosemarie Dearing and seconded by Sandra Thomas to adopt a Resolution for a preliminary inducement to the Albanese Organization in connection with the grant of certain financial assistance to Wyandanch Rising Building E. Mr. Dolan explained the details of this preliminary approval at length. All in favor, motion carried.

Motion was made by Rosemarie Dearing and seconded by Chris Ferencsik to adopt a Resolution giving preliminary approval of the Town of Babylon Industrial Development Agency to grant certain financial assistance to Marc-Robert Industrial LLC and MC Packaging Corp. The Board discussed the project with Mr. Dolan. All in favor, motion carried.

Motion was made by William Bogardt and seconded by Chris Ferencsik to adopt a Resolution authorizing the Agency to execute Mortgage and Security agreement between the Agency, Marc-Robert Industrial, LLC, and M&T Bank in connection with the facility located at 120-200 Adams Boulevard, Farmingdale, NY (M C Packaging Corporation project) in the principal sum not in excess of \$6,200,000 and grant an

exemption from payment of mortgage and recording taxes and fees. A discussion ensued. All in favor, motion carried.

Motion was made by Rosemarie Dearing and seconded by Paulette Moses to adopt a Resolution authorizing the amendment to certain lease agreements the execution of certain mortgages and amendment of existing mortgages with respect to the WR Communities – B project. A lengthy discussion ensued. All in favor, motion carried.
