Waste Systems of Long Island LLC in connection with the acquisition, reconstruction, renovation and equipping of certain solid waste disposal and recycling facilities in the Town of Babylon. The Board members discussed the details of the project. All in favor, motion carried.

Mr. McDonough informed the Members that the Town of Babylon Industrial Development Agency plans to collect and distribute a \$45,974.82 "clawback" on this transaction. A discussion ensued.
