Motion was made by Thomas Nolan and seconded by Nancy Engelhardt to accept the Minutes from the May 28, 2014, IDA/IDC Board Meeting. All in favor, motion carried.

Motion was made by Chris Ferencsik and seconded by Sandra Thomas to accept the minutes from the Public Hearing of Tuesday, June 13, 2014 for Pintail Coffee, Inc., The Marcus Organization, Inc. and MSM Realty Co. III, LLC. All in favor, motion carried.

Motion was made by Ramon Accettella, Jr. and seconded by Sandra Thomas, to adopt a resolution giving preliminary approval of the Town of Babylon Industrial Development Agency to grant certain financial assistance to Island Container Corporation, Combined Container Industries LLC, Yam Realty and 44 Realty Corp. with respect to several facilities located in the Town of Babylon. A discussion ensued wherein the number of employees, type of business and size of building was reviewed. All in favor with one abstention by Chris Ferencsik, motion carried.

Motion was made by Rosemarie Dearing and seconded by William Bogardt to adopt a resolution granting approval of and authorizing the grant of certain financial assistance by the Town of Babylon Industrial Development Agency to Merola Sales Co. Inc. d/b/a Merola Tile and Mero Realty, Inc. in connection with the acquisition, renovation and equipping of an office, warehouse and distribution facility in the Town of Babylon. A

discussion ensued wherein the number of employees, type of business and size of building was reviewed. All in favor, motion carried.

Motion was made by Thomas Dolan and seconded by Nancy Engelhardt to adopt a resolution granting approval of and authorizing the grant of certain financial assistance by the Town of Babylon Industrial Development Agency to Pintail Coffee, Inc., The Marcus Organization, Inc. and MSM Realty Co III, LLC in connection with the leasing, renovation and equipping of an office and manufacturing facility in the Town of Babylon. Mr. Stricoff stated that this is a "qualified use" project. All in favor, motion carried.
